- E. Vos will represent Chen-Wey Precision Industry Corporation in a respectable way and will strive and maintain for a good relationship with existing customers. A list of existing customers as of april 6, 2006 will be agreed upon.
- E. Vos will be paid 5% commission on the sales of products for existing customers. Additional travel expenses will be
 discussed on a case-to-case basis and paid separately when agreed upon.
- E. Vos will sollicit new business for Chen-Wey Precision Industry Corporation for customers located in
 Europe that are not current customers as of april 6, 2006. A list of new customers will be established and updated
 frequently, additions and deletions to this list can be made by mutual agmement;
