3. pls include a statement when a client is not a client anymore (proposed: clients can be removed  
from the list if no PO is placed in 1/2 year)

Reply 3. Clients can be removed from the list if no direct or indirect PO is placed in 5 years.

4. I propose that sales data are submitted within 1 week after the ending of the month

Reply 4. We agree with sales data submit within 1week after the ending of the month but only with the  
sales which you're going to get 3% commission.

Dear Mr. Hsieh,

You have ended our cooperation on July 20-21, 2009, by immediate effect.

After checking commercial code rules we would like to notify you that a relationship may only be terminated with a prior notice period of 3 months in the 3rd through 5th year of a cooperation. This termination can only be effective as of the end of a calendar month. This means that our agreement will officially end on October 31, 2009 and that you are held to pay all commissions as stated in the original agreement of April 6, 2006.

We also would like to notify you that after your writing of September 14 we did not receive any reaction and/or information on the actions requested.

1. we did not receive a correct overview on the data of July 2009
2. we did not receive any data on August 2009 up to know

Based on the fact that you did not submit the monthly data correct or in time on your own accord and not even after the urgent request from our side we have major doubts that future overviews will be submitted correct and in time as well.

We urge you again to submit the correct data on July and the data on August immediately and to confirm that the official ending of the cooperation needs to be October 31, 2009

We also would like to notify you that after your writing of september 14 we did not receive any reaction and or information on the actions requested.
